## **1 OVERVIEW**

- 1.1. This Regional Partnership Agreement (the “Agreement”) is an Agreement between the Anindilyakwa Land Council, the Commonwealth of Australia, the Northern Territory Government of Australia, the East Arnhem Shire Council and the Groote Eylandt Mining Company. Schedule C is between the Anindilyakwa Land Council, Commonwealth of Australia and the Northern Territory Government of Australia.
- 1.2. The scope of this Agreement is the geographic area known as the Anindilyakwa region (the “region”); comprising Groote Eylandt and Bickerton Island, and specifically the communities of Angurugu, Umbakumba and Milyakburra.
- 1.3. This Agreement builds on and replaces the Regional Partnership Agreement signed on 20 May 2008 between the Anindilyakwa Land Council, the Commonwealth of Australia and the Northern Territory Government.
- 1.4. Consistent with the Bilateral Implementation Plan for the National Partnership Agreement on Remote Service Delivery between the Northern Territory and Australian Governments, this Agreement provides the framework for implementation of Remote Service Delivery in Angurugu and Umbakumba. A separate Schedule D will be negotiated and attached to this Agreement as soon as possible outlining how Remote Service Delivery will be implemented in Angurugu and Umbakumba.
- 1.5. This Agreement is made in a spirit of partnership to:
  - 1.5.1. Establish the principles and strategies necessary to improve the coordination and provision of services across the Anindilyakwa region;
  - 1.5.2. Encourage sustained economic development through targeted investments of government, private and royalty funding in education; employment, training and business development; housing; infrastructure and community health and safety;
  - 1.5.3. Establish a framework for implementation including governance arrangements, roles and responsibilities and an evaluation framework;
  - 1.5.4. Set out an agreed plan of action, which aims to achieve measurable and sustainable improvements for people living in the Anindilyakwa region; and
  - 1.5.5. Enable parties to maximise the impact of their respective resources through collaboration and a shared vision of long term economic independence for the Anindilyakwa region.

## **2 KEY PRINCIPLES**

This Agreement is based on the following principles:

- 2.1 Principles agreed in the Heads of Agreement between the parties, signed on 9 November 2006:
  - a recognition of the need for all parties to strengthen effort to address the full extent of Indigenous disadvantage;
  - a spirit of cooperation, partnership and shared responsibility;

- an acknowledgement of the need to build the economic independence of the people in the region;
- a focus on priorities agreed at the regional level;
- a willingness by government to be flexible and innovative;
- a commitment to improvements in accountability and performance monitoring by all parties;
- a desire to achieve clarity of responsibility for service delivery and increased effectiveness across the three levels of government;
- an understanding that greater certainty and stability in funding arrangements, including multi-year funding agreements, can facilitate more effective planning and service delivery mechanisms; and
- a recognition of the need to build capacity and strengthen governance.

2.2 The Service Delivery Principles for Programs and Services for Indigenous Australians, contained in the National Indigenous Reform Agreement. These principles are:

- *Priority principle:* Programs and services should contribute to Closing the Gap by meeting the targets endorsed by COAG while being appropriate to local community needs.
- *Indigenous engagement principle:* Engagement with Indigenous men, women and children and communities should be central to the design and delivery of programs and services.
- *Sustainability principle:* Programs and services should be directed and resourced over an adequate period of time to meet the COAG targets.
- *Access Principle:* Programs and services should be physically and culturally accessible to Indigenous people recognising the diversity of urban, regional and remote needs.
- *Integration principle:* There should be collaboration between and within Governments at all levels and their agencies to effectively coordinate programs and services.
- *Accountability principle:* Programs and services should have regular and transparent performance monitoring, review and evaluation.

### 3 OBJECTIVES AND OUTCOMES

3.1 This Agreement establishes a regional partnership to achieve sustainable and measurable improvements for people living in the Anindilyakwa region across a range of outcomes. The parties will work together to coordinate services and effectively deliver initiatives across communities in the region in response to locally identified need.

3.2 The parties will work together to:

3.2.1 Improve housing outcomes including facilitating the transition from community housing to home ownership, public housing and commercial development;

3.2.2 Improve health service delivery, including enhancing access and availability of services and developing region-specific health interventions;

- 3.2.3 Improve educational outcomes across the region from early childhood to adult education and training;
  - 3.2.4 Improve employment outcomes, including increasing rates of Indigenous people entering and remaining in long-term, meaningful employment;
  - 3.2.5 Enhance opportunities for business and enterprise development in the region;
  - 3.2.6 Enhance community safety, including reducing substance abuse and improving police presence;
  - 3.2.7 Improve the capacity of all organisations in the region through the delivery of governance and leadership training; and
  - 3.2.8 Develop a strong partnership between industry, the community and government that works with Indigenous people locally to generate solutions to complex issues in the region and address obstacles to achieving the objectives of this Agreement.
- 3.3 Plans to achieve the objectives of the regional partnership are set out in the Schedules, or may be set out in additions to the Schedules, or additional Schedules, or may be set out in other documents, such as legal agreements, as appropriate.

#### **4 REGIONAL PARTNERSHIP AGREEMENT COMMITTEE**

- 4.1 The Groote Eylandt and Bickerton Island Regional Partnership Committee will continue its operation to ensure that the parties are working well together toward achievement of the objectives of this Agreement. The Regional Partnership Committee will meet at least quarterly.
- 4.2 The Regional Partnership Committee will comprise senior representatives of each of the parties, including but not limited to the State Managers of the Departments of Families, Housing, Community Services and Indigenous Affairs and Education, Employment and Workplace Relations, Executive Director of Township Leasing, Deputy Chief Executive of the NT Department of the Chief Minister, Chairperson and Manager of the Anindilyakwa Land Council, President and/or Chief Executive Officer of the East Arnhem Shire Council and the General Manager of the Groote Eylandt Mining Company. Additional representatives of the parties may attend meetings as required.
- 4.3 The Regional Partnership Committee will:
- 4.3.1 Provide strategic leadership for the Agreement, ensuring a cohesive approach between parties, stakeholders and people living in the region;
  - 4.3.2 Agree on new priorities and areas for joint action, including leading negotiations on additional Schedules to the Agreement;
  - 4.3.3 Be advised and consulted about any new initiatives the parties propose to undertake that may impact the operation of this Agreement;
  - 4.3.4 Oversee the implementation and performance management of the Agreement, including:
    - monitoring progress of projects contained in the Schedules;

- analysing performance reports and the review mentioned in clause 5.3 of this Agreement;
- ensuring that better outcomes are being delivered through the regional partnership approach; and

4.3.5 Solve any problems and seek to address any lack of progress on implementation.

4.4 The Regional Partnership Committee will meet within two months of signing this Agreement to consider any alterations required to its terms of reference and working arrangements, including:

- membership and Chair;
- secretariat arrangements; and
- any other relevant matter.

## **5 PERFORMANCE MEASUREMENT AND EVALUATION**

5.1 All parties have supported a baseline data study as per Schedule A Part 7 to improve the capacity to measure changes in outcomes in the communities. This study will be replicated to inform the independent evaluation mentioned in clause 5.3.

5.2 Through the Regional Partnership Committee, the parties will jointly monitor and evaluate progress against the timeframes and performance indicators outlined in projects contained in the Schedules to this Agreement. The parties will provide sufficient information to the Committee for that purpose.

5.3 After the first year of operation of this Agreement, the effectiveness of the Agreement will be independently reviewed. The Terms of Reference for the review and the reviewer must be agreed by the Regional Partnership Committee within six months after the Agreement is signed. The core Terms of Reference will be to review the effectiveness of the regional partnership and the impact of the Agreement (and the Agreement it replaces as per clause 1.3) and its Schedules on the people living in the region, with reference to:

- the baseline data study mentioned in clause 5.1 above; and
- the timeframes and performance indicators mentioned in clause 5.2 above.

## **6 ADDRESSING CONCERNS**

6.1 Any Committee member may record a concern on behalf of the stakeholder interests he/she represents. The Regional Partnership Committee as a whole is responsible for ensuring resolution of the concern.

6.2 The procedures for dealing with a concern are as follows:

6.2.1 Where the Committee receives a concern the details must be lodged through the secretariat with the Committee.

6.2.2 The Committee will discuss the concern as a priority and associated responses or actions will be completed in a timely, thorough and fair manner, as appropriate having regard to the nature of the concern.

- 6.2.3 The Committee will ensure that sufficient information and data are gathered to enable a thorough investigation and response and ensure that actions agreed are recorded and carried out.
- 6.2.4 Where a concern cannot be satisfactorily resolved the Committee may appoint an independent, appropriately qualified person to review the issue and advise on the most appropriate course of action to resolve the issue.
- 6.2.5 The Committee should accept the recommendation of the independent advisor.

## **7 DURATION AND AMENDMENT OF AGREEMENT**

- 7.1 This Agreement commences on the date of signing by all parties and will continue in force for five years from that date, or until all of the parties agree to terminate the Agreement or prepare another document that replaces this Agreement.
- 7.2 The members of the Regional Partnership Committee, on behalf of the parties, may amend this Agreement or its Schedules in writing signed by all the members.

<p><b>Project Description:</b> Grant of a township lease over Angurugu, Umbakumba and Milyakburra under section 19A of the <i>Aboriginal Land Rights (Northern Territory) Act 1976</i>.</p>			
<p><b>Project Rationale:</b> To establish long term secure tenure over townships to facilitate certainty for residents, a secure basis for government investment especially in housing and infrastructure, to support better service delivery, to attract private investment and to facilitate business development and home ownership for Anindilyakwa people.</p>

**Part 2 - Working for Better Education Outcomes**

**Project Description:** Funding will be provided for a review of education needs at Groote Eylandt and Bickerton Island jointly supported by the Australian and Northern Territory Governments. The results of the review will inform further work under this Agreement to improve education outcomes in the region.

**Project Rationale:** Improving education outcomes is a critical priority to enhance employment and other life outcomes. All parties agree there is a need to improve education standards in the region, compared to national benchmarks, and improve employment rates.

### Part 3 - Economic Development and Employment Strategy

**Project Description:** The Australian Government, through the Department of Education, Employment and Workplace Relations (DEEWR), will work with the parties to the Agreement to build employment aspirations and the capacity of Indigenous people on Groote Eylandt and Bickerton Island to take up local employment opportunities, remain in jobs and advance their careers.

**Project Rationale:** There is a need to improve the coordination of employment and training services in the region and ensure effective collaboration between stakeholders to enable employment and training opportunities to be fully realised.

## Part 4 - Housing and Development

**Project Description:** Provision of new housing, repairs and maintenance of existing housing and introduction of new housing options including public housing and opportunities for home ownership including delivery of integrated financial management services and assistance. This project will also deliver an increased investment in community development initiatives, through grants for development of a cultural centre and establishment of a local construction company.

**Project Rationale:** The region has been identified by both governments as a priority area for new housing and essential infrastructure to relieve overcrowding and improve living conditions.

## Part 5 - Improving Community Health and Safety

**Project Description:** Increased investment in community health and safety, including enhancing primary health care, development of region-specific health initiatives, increased police presence and introduction of new measures to reduce substance abuse.

**Project Rationale:** It has been identified that current infrastructure is not adequate to meet health service delivery needs and that an increased focus on addressing Machado Joseph Disease (MJD) and dental caries is required. In addition, improving community safety and reducing the use of cannabis have been identified as key priorities by the communities.

**Project Description:** Delivery of innovative leadership development for Indigenous women, men and youth. The leadership workshop will aim to:

- provide an overview of reforms to Indigenous Affairs and its challenges
- provide an interactive learning space focussing on the skills and knowledge needed to meet these challenges and maximise opportunities
- assist participants to develop a vision and plan for the future and
- provide an opportunity for participants to apply what they learn to their community.

**Project Rationale:** Indigenous leaders have indicated their willingness to participate in Shire governance structures and other consultative forums and have requested targeted training be provided at a local level.

### Part 7 - Moving to Stage 2 of the Regional Partnership Agreement

## Part 5 - Economic Participation

**Project Description:** Establish the mechanisms necessary to implement Stage 2 of the Regional Partnership Agreement in a whole of government environment and consistent with commitments in the Remote Service Delivery National Partnership Agreement.

**Project Rationale:** Key principles and objectives of the Remote Service Delivery National Partnership Agreement are consistent with this Regional Partnership Agreement and parties have agreed that the Regional Partnership Agreement will provide the vehicle for remote service delivery reform in the Anindilyakwa region.

## SCHEDULE C

**IMPLEMENTATION AGREEMENT

(SIHIP) IN THE GROOTE EYLANDT ARCHIPELAGO REGION**  
(November 2009)

### **1 Purpose**

- 1.1 The purpose of this agreement is to establish a framework for roles and responsibilities and other mechanisms for managing and implementing the Strategic Indigenous Housing and Infrastructure Program (SIHIP) in the Groote Eylandt Archipelago region. This Agreement provides for a common level of understanding and coordination between the parties to support the objectives of SIHIP.
- 1.2 Once signed, this Agreement will be attached as Schedule C of the Groote Eylandt and Bickerton Island Regional Partnership Agreement. Implementation of this Agreement will be consistent with the principles and objectives set out in the Regional Partnership Agreement.

### **2 Shared Goals**

- 2.1 The Northern Territory Government and the Australian Government share common goals in improving housing outcomes for Indigenous communities in the Northern Territory and these are set out in the National Partnership Agreement on Remote Indigenous Housing.
- 2.2 All parties share the aim of resolving housing overcrowding and improving living conditions in the townships of Angurugu, Umbakumba and Milyakburra and are committed to working together through the Regional Partnership Agreement framework to achieve this aim.
- 2.3 Parties to this Agreement recognise that there are commercial agreements between the Northern Territory Government and the Alliance Partner in relation to the implementation of Stage 1 of SIHIP and the Governments need to work consistently with those agreements.

### **3 Confidentiality**

- 3.1 Consistent with the outcomes of the SIHIP review, parties to this Agreement recognise as a general principle the need for greater transparency and better communication of information about the program to the communities receiving major works.
- 3.2 However, the parties also recognise that some documents and information relating to SIHIP are commercial in confidence and agree that this information will be

treated with appropriate sensitivity. Both governments commit to the principle that relevant information and documentation will not be unreasonably withheld. Parties acknowledge that their employees may be required to sign a deed of confidentiality in order to access relevant documentation and that some commercial information will not be able to be shared across all parties.

#### **4 Declaration of Conflicts**

- 4.1 Parties agree to declare all actual or potential conflicts of interest (whether personal or commercial in nature) and acknowledge that their employees may be required to sign conflict of interest declarations in relation to their roles in SIHIP implementation. Should an employee of a party fail to declare an interest that employee will be immediately excused from any role in relation to SIHIP implementation decision making or representation.

#### **5 Roles and Responsibilities**

- 5.1 The Australian and Northern Territory Governments are jointly responsible for the leadership and program management of SIHIP and implementation of a reformed remote public housing system in Indigenous communities. The Governments will each designate a senior representative to the Alliance Leadership Team for the Alliance Partner ("Government Alliance Representatives") and these representatives will provide a first point of contact for the Anindilyakwa Land Council in respect of any issues with implementation.
- 5.2 Subject to clause 3 above, information on SIHIP implementation will be shared equitably between the Government Alliance Representatives and the Anindilyakwa Land Council. This includes details of the master schedule for the package, package budget and scope, Employment and Workforce Development Plan, Quality Management Framework, Final Designs, outcomes of assessments by the Third Party Panel, Design Guidelines and other relevant policy and guideline documents. Should any relevant information fail to be provided to the Anindilyakwa Land Council, the Chairman or Chief Executive Officer may request an explanation in writing from the Government Alliance Representatives.
- 5.3 The Anindilyakwa Land Council agrees to represent in all discussions and transactions the interests of the communities of Angurugu, Umbakumba and Milyakburra. This includes providing advice and support to the Alliance Partner and parties to this Agreement in respect of community engagement and other matters.
- 5.4 The Australian Government agrees to provide support to community engagement processes including the SIHIP Working Group and Housing Reference Groups through its Government Business Managers and Indigenous Engagement Officers located in the Groote Eylandt Archipelago region.
- 5.5 The Northern Territory Government, through the Department of Local Government and Housing, agrees to provide secretariat and administrative support to the SIHIP Working Group and Housing Reference Groups in the region including convening meetings, settling terms of reference, distributing papers and agendas ahead of meetings and circulating records of meeting.

5.6 The roles and responsibilities of each party will be specified in greater detail under the community engagement plan mentioned at 6.1.3.

## **6 Priority Areas of Attention – Stage 1 SIHIP Implementation**

6.1 In the implementation of Stage 1 of SIHIP, the parties commit to the seven SIHIP objectives and the rationale underpinning the selection of a Strategic Alliance methodology, including the ability to drive down prices, reduce delivery times, attract larger national companies with capacity to partner with smaller companies with local expertise, use local labour and engage effectively with the community. It is recognised that these areas require further and more immediate attention within the overall framework of SIHIP implementation in the Groote Eylandt Archipelago region. To address these issues, parties agree to the following:

6.1.1 Consistent with Stage 1 of the Regional Partnership Agreement, twenty-six new houses will be constructed in Stage 1 of SIHIP, including eighteen at Angurugu, six at Umbakumba and two at Milyakburra. While the designs and costs of these houses have been approved by the Australian and Northern Territory Governments, the parties undertake to conduct a final assessment of the designs by the end of October with a view to identifying any improvements.

6.1.2 Funding is available within the package budget for a minimum of 75 refurbishments and rebuilds of houses in Angurugu, Umbakumba and Milyakburra in Stage 1. Refurbishments will address immediate safety issues and focus on improving functionality of health hardware in houses. Parties to this Agreement will work with the SIHIP Working Group and Alliance Partner to determine the scope and priorities for refurbishments according to agreed criteria based on the prioritisation of works to maximise measurable impact on addressing critical healthy living practices across as many houses as possible. The criteria for rebuilds and refurbishments will be overlaid by an assessment of tenant need particularly where this relates to disability access. An agreed scope of works for refurbishments and rebuilds will be finalised within two months of signing this Agreement.

6.1.3 Parties to this Agreement will cooperatively develop and implement a community engagement plan for SIHIP in the Groote Eylandt Archipelago region, to be agreed within one month of signing this Agreement. Items that are to be addressed include:

- The process for consultation with the Groote Eylandt communities of Angurugu, Umbakumba and Milyakburra about the draft Remote Public Housing Management Framework to ensure that the changes are understood and to provide a chance to identify any matters that may impact adversely on the Groote Eylandt Archipelago region.
- The role, terms of reference and working arrangements for the SIHIP Working Group and Housing Reference Groups.

- Processes to ensure the communities of Angurugu, Umbakumba and Milyakburra and other relevant stakeholders are informed about Stage 1 of SIHIP implementation in the Groote Eylandt Archipelago region.
- 6.1.4 The SIHIP Implementation Group mentioned at Clause 8 below will work to establish an agreed information sharing protocol which clearly documents how information on SIHIP will be shared between the SIHIP Implementation Group, SIHIP Working Group and the broader community and other relevant stakeholder groups. The protocol will be in place within one month of signing this Agreement.
- 6.1.5 Noting that a minimum overall target of 20% local Indigenous employment has been set for Stage 1 of SIHIP in the Groote Eylandt Archipelago region, parties to this Agreement will cooperatively develop and implement an agreed employment and workforce development plan within one month of signing this Agreement.
- 6.1.6 The Government Alliance Representatives will work through the quality assurance process for Stage 1 of the SIHIP package with the Anindilyakwa Land Council and the Alliance Partner. Where it is agreed that additional quality assurance elements are required for SIHIP works in the Groote Eylandt Archipelago region, the Government Alliance Representatives will develop in conjunction with the Anindilyakwa Land Council these elements ensuring that they are consistent with the overall program management framework and provide confidence to all parties about the quality of new housing and renovations constructed through SIHIP.
- 6.1.7 Both governments, following consultation with the Anindilyakwa Land Council, agree to urgently address the issue of eligibility for home ownership where refurbishments are completed under Stage 1 to bring houses up to a safe and habitable standard.

## **7 Priority Areas of Attention – Stage 2 SIHIP Implementation**

- 7.1 The Australian and Northern Territory Governments have announced a commitment of 54 new houses for the communities of Angurugu, Umbakumba and Milyakburra, additional to the 26 committed in Stage 1. In relation to implementation of this commitment, parties agree to the following:
- 7.1.1 The parties agree that the Anindilyakwa Land Council will be part of the decision making process for an Alliance Partner for Stage 2, consistent with the spirit and objectives of the Regional Partnership Agreement, the substantial size of the investment and the concerns of the Anindilyakwa Land Council in respect of Stage 1.
- 7.1.2 The Australian and Northern Territory Governments will provide the total allocation for new houses and target unit cost to the Anindilyakwa Land Council by 31 December 2009.
- 7.1.3 An employment and workforce development strategy, building on outcomes of Stage 1 and setting new targets of not less than 20% local Indigenous

employment, will be developed in consultation with the Anindilyakwa Land Council by 31 March 2010.

7.1.4 Processes for quality assurance will be reviewed by all parties and amended as necessary to apply to Stage 2 implementation, prior to any works being commenced.

7.1.5 Subject to clause 3 above, the Anindilyakwa Land Council will have an opportunity to view and comment on the draft Package Development Report for Stage 2 of SIHIP in the Groote Eylandt Archipelago region prior to it being finalised and is entitled to receive a final copy for their records.

## **8 Dispute Resolution**

8.1 Any party may raise a concern with the operation of this Agreement. The concern will be provided in writing to the Alliance Leadership Team through the Chairman or Chief Executive Officer of the Anindilyakwa Land Council or through one or both of the Government Alliance Representatives. The Alliance Leadership Team must provide a written response to all parties within fourteen days of receiving it.

8.2 If the party is dissatisfied with the response from the Alliance Leadership Team, the party may escalate the concern to the Groote Eylandt and Bickerton Island Regional Partnership Committee through one of the co-Chairs. The processes for dealing with the concern are as set out in Clause 6 of the Regional Partnership Agreement.

## **9 Monitoring and Reporting**

9.1 A SIHIP Implementation Group will be established comprising the Government Alliance Representatives, a senior representative of the Alliance Partner and the Chairman and Manager of the Anindilyakwa Land Council. Representatives may invite their technical advisors to attend meetings.

9.2 The Group will meet at least monthly to discuss progress of this Agreement and monitor the timelines and actions set out in Parts 5 and 6 above. The Group will provide quarterly reports on progress to the Regional Partnership Committee through the Secretariat.

9.3 The SIHIP Implementation Group will meet within one week of signing this Agreement to determine its terms of reference and working arrangements. Items to be considered include processes for decision making, recording and distribution of decisions and actions.

## **10 Effective Date**

10.1 This Agreement will be effective upon signing by all parties. The Agreement will be reviewed after two years from the date of signing and extended by written agreement of the parties if necessary. The Agreement may be amended at any time by consent of all parties in writing.
