CONDITIONS OF REGISTRATION

By signing this form below, you are taken to accept and adhere to the following conditions:

1. Provide a Veterinary Certificate or Statutory Declaration stating the dog(s) have been de-sexed and vaccinated. Provide Micro-chip Number if applicable.
2. Provide a colour photo of the dog(s).
3. Ensure the registration tag(s) is attached to the dog(s) at all times.
4. Ensure no more than two dogs are kept at the premises at any time.
5. Take all necessary precautions to ensure the dog(s) does not interrupt the enjoyment of others.
6. Take all necessary precautions to ensure the dog(s) does not attack, menace or bite any person or animal.
7. Ensure the dog(s) is contained within the house block at all times using appropriate enclosures/fencing and restrained on a suitable lead or under the control of a responsible person when not within the house block.
8. Any damage to the property caused by the dog(s) is rectified at the tenant's expense prior to vacating the property or as agreed between GEMCO and the tenant.
9. Any cost of removing fleas and ticks from the dog(s) and premises is the tenant's responsibility.
10. If a dog(s) is found roaming outside the registered premises and the owner or the alternate contact are not able to be contacted, the dog(s) will be referred to the local Veterinary service after three days to determine the future welfare of the dog(s).
11. If an incident involving dog(s) is deemed to be of a serious nature, GEMCO has the right to ask the owner(s) to remove the dog(s) from the Special Purpose Lease at the owner's expense.

Please note: A failure to comply with the above conditions may result in the registration being cancelled and the dog being removed from Groote Eylandt at the owner's expense.
