

## **SENATE ORDER ON ENTITY CONTRACTS**

### **Financial Year Senate Order on Entity Contracts Listing (relating to the period 1 July 2022 to 30 June 2023).**

Pursuant to the Senate Order on Entity Contracts the following table sets out contracts entered into by the Anindilyakwa Land Council which provide for a consideration to the value of \$100,000 or more (GST inclusive) which:

- a. have not been fully performed as at 30 June 2023, or
- b. which have been entered into during the 12 month reporting period.

Most of the contracts listed contain confidentiality provisions of a general nature that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract.

The reasons for including such clauses include:

- a. ordinary commercial prudence that required protection of trade secrets, proprietary information and the like; and/or
- b. protection of other Commonwealth material and personal information.

The Accountable Authority of the Anindilyakwa Land Council has assured that the listed contracts do not contain any inappropriate confidentiality provisions.
